Description of Agenda Item:

The attached financial report is intended to provide the EDC with an overview of the EDC's current finances.

Year-To-Date Budget Report

The Year-To-Date Budget Report compares budgeted and actual year-to-date revenues and expenditures. In reviewing the year-to-date revenues and expenditures in the Report, the EDC should note that 67% of the 2020-2021 budget year has transpired.

Sales Tax Revenue Analysis

The Sales Tax Revenue Analysis tracks the collection of sales tax revenue and compares current year sales tax collections with prior year collections. Annual sales tax collections are higher than projected. Sales Tax Revenue for the months of October 2020 and November 2020 are directly related to last fiscal year; therefore, these amounts are not part of the FY 2020-21 financials. For fiscal year 2020-21, the EDC sales tax revenue received through May 31, 2021 is \$115,077.99. On the cash basis, the EDC sales tax revenue received is \$139,834 from October 2020 through May 31, 2021, which represents an increase of \$43,366.85 or 45% from October 2019 through May 2020.

EDC Fund Balance

As of May 31, 2021, the balance of the EDC Fund is \$920,226.81.
